**Subject to finalization of basis of allotment*

This is in relation to the proposed initial public offer of a fresh issue of up to 2,09,00,000 Equity Shares of face value of ₹ 10/- each ("Equity Shares") of the Company for cash at a price of ₹[●] per Equity Share (including a securities premium of ₹ [●] per Equity Share) ("Offer Price") aggregating up to ₹[●] lakhs (the "Offer"). The Offer comprises of a fresh issue of up to 1,46,50,000 Equity Shares aggregating up to ₹ [●] lakhs (the "Fresh Issue") and an Offer for Sale of up to 62,50,000 Equity Shares (the "Offered Shares") aggregating up to ₹ [●] lakhs by the Shankarlal Deepchand Mehta ("Promoter Selling Shareholder" or "Selling Shareholder") ("Offer For Sale").

The Company and the Selling Shareholder are proposing to undertake the Offer through the book building process in compliance with Regulation 6(1) of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the "SEBI ICDR Regulations"), at such price as may be determined in accordance with the book building process, by the Company and the Selling Shareholder, in consultation with the BRLMs (defined below), and pursuant to Rule 19(2)(b) of the Securities Contracts (Regulations) Rules, 1957, as amended ("SCRR") and other applicable laws.

The Company and the Selling Shareholder have appointed Nirbhay Capital Services Private Limited as the book running lead manager (the "BRLM") to manage the Offer.

The Company and Selling Shareholder have appointed Kfin Technologies Limited to act as the Registrar to the Offer ("Registrar").

We are filing the draft red herring prospectus dated June 19, 2025 (the "Draft Red Herring Prospectus" of the "DRHP") in relation to the Offer for your consideration and observations. All capitalised terms used herein and not specifically defined have the same meaning as ascribed to such terms in the DRHP.



TRUST WITHOUT FEAR

In connection with the filing of the DRHP with the Securities and Exchange Board of India ("SEBI"), we hereby submit the following:

1. The soft copy of the DRHP in ".PDF" format signed and executed by all the directors of the Company (the "Directors"), the Chief Financial Officer of the Company and the Selling Shareholder ("Annexure I"), accompanied by this letter and all annexures hereto, is submitted by way of an e-mail to the SEBI at cfddil@sebi.gov.in, in accordance with the instructions issued by SEBI on March 27, 2020, in relation to "Easing of Operational Procedure - Division of Issues and Listing - CFD". Such documents will also be uploaded on the SEBI intermediary portal at <https://siportal.sebi.gov.in>, as specified in Regulation 25(8) of the SEBI ICDR Regulations and as required pursuant to the SEBI circular (bearing number SEBI/HO/CFD/DIL1/CIR/P/2018/011) dated January 19, 2018. All online payment will be made in accordance with the "Easing of Operational Procedure" issued by SEBI dated August 11, 2021.
2. A certificate from the Book Running Lead Manager in accordance with Regulation 25(2)(a) of the SEBI ICDR Regulations confirming that the Company, the Selling Shareholder and the BRLM have entered into an Offer Agreement dated May 26, 2025, in accordance with Regulation 23(5) of the SEBI ICDR Regulations and the format specified in Schedule II of the SEBI ICDR Regulations (Annexure II).
3. A due diligence certificate dated June 19, 2025 signed by the BRLM in accordance with Regulation 25(2)(b) of the SEBI ICDR Regulations (Annexure III), along with (i) a due diligence process note as required under Form A of Schedule V of the SEBI ICDR Regulations (Annexure III-A); (ii) a detailed checklist indicating compliance of the disclosures in the DRHP with the applicable provisions of the SEBI ICDR Regulations (Annexure III-B) and (iii) a confirmation from BRLM in accordance with SEBI directive dated May 29, 2024 issued to AIBI (Annexure III-C).
4. The Company had proposed fresh issue of up to 1,46,50,000 equity shares and offer for sale of up to 62,50,000 equity shares. The exact issue would be determined after the closure of book building process. Accordingly, the issue size is not known as of now. However, for determining the filing fees under Schedule III of the SEBI ICDR Regulations, we have relied on the amount proposed to incurred towards objects of the issue, which is estimated to ₹ 11,632 Lakhs being the fresh issue portion. Based on amount proposed to be raised for objects of the offer and estimated number of shares to be issued, we have arrived at amount proposed to be raised through offer for sale. We believe, that ₹ 25,100 Lakhs would be the estimated total issue size. The Company will make a payment of ₹ 29.62 Lakhs (comprising of fees of ₹ 25.10 Lakhs towards filing fees and ₹ 4.52 Lakhs towards GST), being 0.1% (plus applicable taxes) of the estimated Offer size towards filing fees under Schedule III of the SEBI ICDR Regulations, through the relevant payment link on the SEBI Intermediary Portal towards DRHP Filing fees as provided under Schedule III of the SEBI ICDR Regulations and the payment details will be subsequently intimated. As the Offer Price of Equity Shares will be determined through the Book Building Process, and pursuant to Schedule XVI of the SEBI ICDR Regulations, we are unable to ascertain the actual Offer size at this stage. Accordingly, the filing fee is based on an estimated Offer size of up to ₹ 25,100 Lakhs, and the same should not be construed as the final Offer size for the purposes of Schedule XVI of the SEBI ICDR Regulations.

Further, we are also submitting a copy of the registration certificate issued to the Company under Goods and Services Tax Act, 2017 (Annexure IV) and details in relation to such registration (Annexure IV-A).



In connection with the Offer, please note the following:

A. Unified Payments Interface ("UPI")

The Offer is to be undertaken pursuant to the processes and procedures under phase III of the UPI framework under the relevant SEBI circulars. Further, the DRHP has been drafted in accordance with phase III of the UPI framework, and also reflects additional measures for streamlining the process of initial public offers, as prescribed under SEBI circular no. SEBI/HO/CFD/DIL2/CIR/P/2018/138 dated November 1, 2018 read with SEBI circular no. SEBI/HO/CFD/DIL2/CIR/P/2019/50 dated April 3, 2019, SEBI circular no. D. Confirmation in relation to securities law violation





ANNEXURE III-A

Note explaining the process of due diligence that has been exercised

We, the BRLMs, have carried out a due diligence exercise on the Company for the purposes of complying with the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended ("SEBI ICDR Regulations") and other applicable laws, and to the extent customary for initial public offerings in India, along with other professionals and experts engaged in the Offer. All capitalized terms used herein and not specifically defined shall have the same meanings ascribed to such terms in the draft red herring prospectus dated June 19, 2025 ("DRHP").

The due diligence process carried out by us commenced with multiple in-person meetings alongwith virtual interactions with the senior management of the Company (the Promoter Selling Shareholders (which includes the Chairman and Managing Director, Chief Financial Officer, Chief Executive Officer, Company Secretary and Compliance Officer, other members of the senior management of the Company) to gain an understanding of, among other matters, industry dynamics, the business and operations of the Company, assessing strengths and critical risks involved, and financial overview, and the background of Company's management and its promoter / promoter group. In this regard, we provided the Company with a due diligence questionnaire and information request list prepared in consultation with legal counsel. In response to the questionnaire and the information requisition list, the Company provided us with supporting documents on virtual data room and in accordance with the questionnaire for our review and gave us explanations for our queries. The Online and off-line diligence was done by us along with Legal Counsel i.e. Vidhigya Associates and documents were reviewed and clarifications were sought.

In connection with the Offer, Vidhigya Associates has been appointed as the legal counsel to the Offer ("Legal Counsel"). The Legal Counsel have assisted us in carrying out legal due diligence, drafting of the DRHP in compliance with the SEBI ICDR Regulations and other applicable laws, and advised the Company and us on other legal matters, as appropriate in the Issue. We were also assisted by the current statutory auditor of the Company, M/s Ruparel & Bavadiya, Chartered Accountants ("Statutory Auditor") in financial due diligence. In addition to the restated financial information of the Company, the Statutory Auditor has verified and certified certain matters relating to, *inter alia*, statement of special tax benefits available to the Company, and its shareholders and corporate governance compliance of the Company. The Statutory Auditor has verified and certified certain matters relating to, *inter alia*, key performance indicators and operational information about the Company, outstanding borrowings of the Company, details of any amounts outstanding to micro, small and medium enterprises and other creditors of the Company.

The Company has received written consent dated June 12, 2025, from the Statutory Auditors, M/s. Ruparel & Bavadiya, Chartered Accountants, who holds a valid peer review certificate, to include its name as required under Section 26 of the Companies Act, 2013 in this Draft Red Herring Prospectus and as an "expert" as defined under Section 2(38) of the Companies Act, 2013 in respect of (i) the examination reports on the Restated Financial Statement and their examination report dated June 7, 2025; and (ii) the Statement of Possible special tax benefits dated June 12, 2025, included in this Draft Red Herring Prospectus and such consents have not been withdrawn as on the date of this Draft Red Herring Prospectus. The Company has also placed reliance on the report titled "Industry Report On Indian Stainless Steel" dated June 4, 2025 issued by Dun & Bradstreet ("D&B"), for disclosures relating to the industry information in the DRHP. This industry report has been commissioned and paid for by the Company exclusively for the purposes of confirming the Company's understanding of the industry in connection with the Offer. Further, the Company has received a written consent from D&B dated June 4, 2025, to include extracts of the D&B Report and other industry information in the DRHP, Red Herring Prospectus and Prospectus. The Company had also appointed JAS Associates who is an Independent Chartered Engineer and he has also provided a written consent dated May 15, 2025 to include their name as an expert.




The Company proposed to utilise offering proceeds interlia towards capital expenditure and repaying of debt. In addition to business diligence, we have relied on Chartered Accountant certificates, D&B to assess capital expenditure requirement and bank correspondence to assess outstanding debt with Company.

The Statutory Auditors have consented to be named as experts, in terms of the Companies Act, 2013, as amended, in the DRHP and such consent has not been withdrawn as at the date of filing of the DRHP with the SEBI.

1. *Business and Commercial Diligence*

The due diligence process in relation to general business and commercial matters included:

- (a) Organizing and attending a kick-off discussion with the Company to develop an understanding of the business, history and other matters of the Company, and the industry overview and the regulatory environment, which were attended by members of the Company team, BRLM, Legal Counsel and the Statutory Auditor. Physical visit was conducted of the manufacturing facility and Registered Office of the Company. A broad overview of the business of the Company, the industry in which they operate, the regulatory framework with respect to their businesses, the corporate structures, capital structure, financials and shareholding pattern of the Company was were presented, followed by interactive discussions. We have perused the documents and correspondence in support of representations made by Company. We were supported by Statutory Auditors, Legal Counsel and D&B to validate and understand overall business of Company.
- (b) Regularly interacting with the Company's senior management including the Chief Financial Officer, other Key Managerial Personnel, as well as other individuals from the Company's business, secretarial, legal and finance departments, and the Statutory Auditor for the purpose of gaining an understanding about, among other matters, the business, the risks involved and the financial overview of the Company. These interactions included (i) due diligence calls, virtual drafting sessions and conference calls to discuss the draft disclosures in the DRHP; (ii) due diligence calls with the Statutory Auditor of the Company; (iii) bring down due diligence call to receive updated information from the Company before filing the DRHP; (iv) seeking appropriate certifications from the Company, its Directors, Promoters, Promoter Group, Key Managerial Personnel and Group Companies. These interactions were conducted with the objective of assisting the Company to prepare the disclosures as required under the SEBI ICDR Regulations and other applicable laws with regard to the Issue. We shall continue to undertake these interactions and due diligence calls until the allotment of Equity Shares in the Offer.
- (c) Interacting with the industry consultant, namely D&B and M/s JAS Associates who is a certified chartered engineer.
- (d) Requesting the Company to provide documents based on the requirements under the SEBI ICDR Regulations. Assisting the Company to make available due diligence documents in a virtual data room (google drive) or share through e-mails and reviewing those documents along with the Legal Counsel, to comply with the diligence requirements as stipulated under the SEBI ICDR Regulations, and the other applicable laws, as is customary in such transactions.
- (e) Physical meetings along with Virtual interactions with the Key Managerial Personnel and other senior personnel of the Company to understand the Company's day to day operations, key business processes and to verify the disclosures being made in the DRHP.
- (f) Obtaining certificates, confirmations, formal representations and undertakings from the Company, its Directors, Promoter, Promoter Group, Key Managerial Personnel, the Group Companies, the



Statutory Auditor, and other documents, and corroborating with other evidence available in support of certain disclosures made in the DRHP.

- (g) Reviewing, together with the Legal Counsel, certain business-related documents pertaining to the Company, including (i) purchase order with customers and suppliers and manufacturing units each on a sample basis, if any, and (ii) various internal policies pertaining to its business operations, as adopted and implemented by the Company.
- (h) Regular interactions with the Company management including the Promoters. These interactions included (i) virtual and physical due diligence meetings and calls, drafting sessions and conference calls to discuss the disclosures in the DRHP, (ii) due diligence calls with the Statutory Auditors; (iii) seeking appropriate clarifications and certifications from the Company for key financial, operational data and other information and also interacting and seeking appropriate clarifications from Practising Company Secretary and Company Secretary and Compliance Officer; (iv) seeking appropriate certifications from Statutory Auditor for key operational data, amongst others; (v) Obtaining circle-ups from the Statutory Auditor on financial information as well as certifications for the operational data and certain financial related information included in the DRHP, as on and for the periods specified therein; and (vi) interacting with the industry consultant, namely D&B India, for the purposes of industry report used in the DRHP. These interactions were conducted with an objective to assist the Company to prepare disclosures as required under the SEBI ICDR Regulations, the Companies Act, 2013, and other applicable laws with regard to the Offer. We expect these interactions and due diligence calls and discussions to continue until closure of the Offer. Accordingly, disclosures in respect of the business carried out by the Company as well as associated risks in relation thereto, have been made in the sections titled "*Our Business*" and "*Risk Factors*" in the DRHP;
- (i) Obtaining and relying on certificates and formal representations and undertakings from the Company, Directors, Promoter, members of the Promoter Group, Key Managerial Personnel, Statutory Auditor, and other documents, including extracts of report by independent industry sources, in support of certain disclosures included in the DRHP;
- (j) Obtaining and relying on formal representations and undertakings from the Company in the Offer Agreement;
- (k) For certain information, relying on management certificates from the Company for ensuring compliance with the SEBI ICDR Regulations;
- (l) For certain information, relying on management certificates from the Company for compliance with the SEBI ICDR Regulations.
- (m) Visiting the Company's registered office and Manufacturing Facility, for diligence purposes.

2. *Industry Information*

We have relied on industry and market data derived from the report titled "*Industry Report On Indian Stainless Steel*" exclusively prepared and issued by D&B India, dated June 4, 2025 which has been commissioned by the Company for the purposes of confirming its understanding of the industry in connection with the Offer. The D&B Report has been commissioned and paid for by the Company and has been prepared exclusively for the purposes of disclosures in the "*Industry Overview*" section of the offer documents.



We have also interacted with D&B India and held due diligence calls and received responses from them in relation to certain diligence questions in relation to the contents of the D&B Report. The industry related information contained in certain sections of the DRHP, including "Risk Factors", "Industry Overview", "Our Business" and "Management's Discussion and Analysis of Financial Condition and Result of Operations", have been included from D&B Report.

The D&B Report will be available on the website of the Company at www.rajputanastainless.com, in accordance with applicable law and has been included as one of the documents that will be available as a material document for inspection.

3. **Outstanding Litigation Proceedings and Material Creditors**

We have disclosed outstanding litigations involving the Company, Directors, Promoters, the Key Managerial Personnel (KMPs), Senior Managerial Personnel (SMPs), Group Company as required under the SEBI ICDR Regulations and in accordance with the policy on materiality approved by the Board of Directors vide resolution dated April 21, 2025 ("**Materiality Policy**"). The Company, its Directors, the Promoters, the KMPs and SMPs and the Group Company are referred as "Relevant Parties".

In accordance with the Materiality Policy, all outstanding litigation, including any litigation involving the Relevant Parties, other than criminal proceedings, actions by regulatory authorities and statutory authorities, claims relating to direct and indirect taxes or disciplinary actions including penalties imposed by SEBI or stock exchanges against the Company, the Directors, the Promoters, and the Group Companies, including outstanding action; will be considered material if:

(A) the omission of an event or information, whose value or the expected impact in terms of value exceeds the limits as prescribed under the SEBI Listing Regulations (as amended from time to time) i.e. (a) two percent of turnover, as per the last annual restated financial statements of the Company; or (b) two percent of net worth, except in case of the arithmetic value of the networth is negative, as per the last annual restated financial statements of the Company; or (c) five percent of the average of absolute value of profit or loss after tax, as per the last three annual restated financial statements of the Company.

Accordingly, any transaction exceeding the lower of a, b or c above will be considered for the above purpose; or

(B) where the decision in one case is likely to affect the decision in similar cases, even though the amount involved in individual litigation does not exceed the amount determined as per clause (i) above, and the amount involved in all of such cases taken together exceeds the amount determined as per clause (i) above; and

(C) any such litigation which does not meet the criteria set out in (i) above and an adverse outcome in which would materially and adversely affect the operations or financial position of the Company.

It is clarified that for the above purposes, pre-litigation notices received by Relevant Parties, unless otherwise decided by our Board, are not evaluated for materiality until such time that the Relevant Parties are impleaded as defendants in litigation proceedings before any judicial forum.

The Company has provided a list of outstanding litigation involving the Company and supporting documents for material proceedings involving the Company. Further, we interacted with the relevant representatives of the Company to understand the status of various pending proceedings involving the Company.



As described above, outstanding legal proceedings in relation to direct and indirect taxes have been disclosed in a consolidated manner giving details of number of cases and total amount involved, except in relation to material tax litigation which are disclosed separately. With respect to such proceedings, we have relied on a list provided by the Company. For disclosures relating to litigation involving the Directors, Promoter, KMPs, SMPs, and Group Companies, the Company has provided certifications received from such persons/ entities.

Further, with respect to outstanding dues to micro, small and medium enterprises, material creditors and other creditors of the Company, a consolidated disclosure providing the total number of creditors (material and otherwise) and amounts due to such creditors, as on December 31, 2024, has been made in the DRHP. Further, in compliance with the SEBI ICDR Regulations, the details pertaining to the outstanding dues to material creditors as on December 31, 2024, are also available on the website of the Company at www.rajputanastainless.com. We along with Legal Counsel also carried out background check on management, promoter and promoter group through www.watchoutinvestors.com and CIBIL checks as applicable. We have also obtained 3rd party litigation reports from 3rd party vendor for promoters, directors and group companies.

In accordance with the SEBI ICDR Regulations, in respect of litigation involving the Group Companies, the Company is required to disclose only such litigation that can have a material impact on the Company. In this regard, we have obtained certification from the Group Companies that, as on the date of the DRHP, there is no litigation involving the Group Companies that could have a material impact on the Company.

4. **Key Performance Indicators**

Suitable disclosures have been made in line with the recent amendments to the SEBI ICDR Regulations in relation to key performance indicators of the Company and weighted average cost of acquisition of its Equity Shares in the section titled "Basis for Offer Price" and other relevant sections in the DRHP. Further, such key performance indicators were approved by the Audit Committee of the Company pursuant to its resolution dated June 9, 2025. Such key performance indicators disclosed by the Company have been certified by the Statutory Auditor, holding a valid peer review certificate, and such certificate shall form part of the material documents for inspection by the public in connection with the Offer. The Company shall continue to disclose such key performance indicators, on a periodic basis, at least once in a year (or for any lesser period as determined by the Company), for a duration of one year after the date of listing of the Equity Shares, or until the utilisation of the Offer proceeds, whichever is later, in accordance with the SEBI ICDR Regulations.

5. **The Company, Promoter Selling Shareholder, Promoters, Promoter Group, Group Companies, Directors and Key Managerial Personnel and Senior Managerial Personnel of the Company**

For the purposes of making certain disclosures with respect to the Company, Promoter Selling Shareholder, Promoters, the Promoter Group, Group Company, Directors, Key Management Personnel and the Senior Managerial Personnel of the Company in the DRHP, we have obtained supporting documents and certifications from the relevant entities/persons.

In relation to the educational qualifications, previous employment and professional experience of Directors, Promoters, KMPs and SMPs, we have relied on relevant transcripts, degree certificates, experience certificates, MCA information for directorships, and appointment letters issued by previous and current employers and other back-up documents as applicable.

In addition, we have received confirmation from the Company, Promoter Selling Shareholder, Promoters, Directors and members of the Promoter Group stating that they have not been prohibited or debarred



from accessing the capital markets or debarred from buying, selling or dealing in securities under any order or direction passed by SEBI. Further, we received confirmations from the Company, Directors and Promoters that they have not been identified as wilful defaulters as defined under the SEBI ICDR Regulations. Further, confirmations have been taken from Directors that (a) they are not Directors on the board of other listed companies whose shares have been / were suspended from being traded on the BSE Limited and/or the National Stock Exchange of India Limited during the period of five years before the date of the DRHP; (b) that they are not currently or were previously on the board of a listed company whose shares have been or were delisted from being traded on any stock exchange while they were directors of such companies. Further, we have received confirmations from the Directors that they have not been identified as a 'fugitive economic offenders' as defined under the SEBI ICDR Regulations and the Directors and Promoters that they have not been identified as "fraudulent borrowers" in terms of RBI master circular dated July 1, 2016. Confirmations have also been obtained from the Company and Promoter Selling Shareholder, in respect of their compliance with the Companies (Significant Beneficial Owners) Rules, 2018, to the extent in force and applicable to such party, as on the date of the DRHP.

Pursuant to a resolution of the Board and as per the SEBI ICDR Regulations, for the purpose of identification of group companies, the Company has considered (i) the companies with which there were related party transactions as per Ind AS 24, as disclosed in the Restated Financial Information; and (ii) other companies considered material by the Board pursuant to the Materiality Policy.

As per the provisions of the SEBI ICDR Regulations, the Company is required to provide links of the website of the Group Companies where financial information of the Group Companies has been disclosed. Accordingly, the financial information of the Group Companies has been disclosed on the website of the Company.

The Promoter Selling Shareholder, in relation to the notice for participation in the offer for sale, containing terms and conditions for the Offer including eligibility conditions for participation in the Offer, the Company has received consent letters, along with the relevant information and documents which include, authorization from each Promoter Selling Shareholder to participate in the Offer and various confirmations, covenants, representations and warranties, as required from each Promoter Selling Shareholder.

6. ***Financial information of the Company and financial indebtedness***

We have conducted due diligence on financial matters, which included virtual meetings and a due diligence call with the Statutory Auditor, and the finance team of the Company, review of the reports and other related documents from the Statutory Auditor. The Statutory Auditor has provided the Restated Financial Statements of the Company, which were audited in accordance with the relevant ICAI requirements and the Companies Act, 2013 and restated in accordance with the SEBI ICDR Regulations for the fiscal years 2022, 2023 and 2024 and nine months ended December 31, 2024 (and provided an examination report thereon). We reviewed the Restated Financial Statements of the Company and the examination report, and the audited financial statements and the audit report issued thereon by the Statutory Auditor and obtained certifications with respect to certain information included in the DRHP from the Statutory Auditor. We held discussions with the Statutory Auditor on the form and manner of the reports and certifications required for such financial information.

The Statutory Auditor was also required to review the financial information relating to the Company in the DRHP in the relevant periods and have delivered customary comfort letters to the BRLMs confirming the accuracy of such financial information contained in the Company. Such comfort letters will be re-issued or brought down at certain future dates, as the Offer progresses, by the Statutory Auditor, prior to the filing of the RHP, the Prospectus and the Allotment of Equity Shares in the Offer.



We had also conducted a due diligence exercise of all outstanding financial indebtedness of the Company, and such information (including principal terms of borrowings, as applicable) has been disclosed in summarised form in the section titled "*Financial Indebtedness*" of the DRHP. In this connection, we have reviewed the relevant financing related documents from the lenders. We have also relied on a certificate from the Statutory Auditor in connection with the Company's financial indebtedness, ascertaining the amount of outstanding borrowings of the Company, which is disclosed in the section titled "*Financial Indebtedness*" of the DRHP.

In addition, as per the requirements of the SEBI ICDR Regulations, the Company has uploaded the following on its website (www.rajputanastainless.com) (i) the audited financial statements of the Company for past three fiscals; and (ii) the details of its material creditors, in accordance with the materiality policy adopted by the Board of the Directors of the Company.

We have relied on the statement of possible special tax benefits to the Company and its shareholders issued by the Statutory Auditors.

7. ***Statutory and/or Regulatory and Other Diligence***

In connection with due diligence of statutory and/or regulatory matters, we have along with the Legal Counsel, reviewed the relevant statutory and/or regulatory records of the Company, including without limitation, relevant corporate records, filings made by the Company with various key statutory and/or regulatory authorities, licenses, approvals and registrations applied for and/or received by the Company and such other documents as we have deemed necessary and as have been provided to us by the Company from time to time and have made suitable disclosures, as prescribed, in relation to relevant findings. We have also relied on representations and certifications provided by the Company in connection with such statutory and/or regulatory matters.

We, along with the Legal Counsel, have reviewed material licenses, approvals, registrations, applied for and/or received by the Company, and property documents executed by the Company to undertake its business activities as mentioned above. We have relied on the list of material licenses, properties, approvals and registrations of Company, identified by the Company for purposes of our due diligence.

In relation to the trademarks registered in the name of the Company, we have relied on the details provided by the Company. We along with the Legal Counsel have reviewed the trademark application of the Company.

The description of the material approvals required for the business operations and disclosure of such material approvals in respect of which applications have been made and approvals for which applications have not been made has been disclosed in the DRHP. We have appropriately disclosed details of such approvals in the sections titled "*Government and Other Approvals*" and "*Risk Factors*" of the DRHP.

8. ***Objects of the Offer***

The Company proposes to utilize the Net Proceeds from the Offer towards funding the following objects:

- (1) Funding capital expenditure requirements for setting up of manufacturing facility for Stainless Steel Seamless Pipes to expand our product portfolio ("**Proposed Facility**"),
- (2) Full or part repayment and/or prepayment of certain outstanding secured borrowings availed by our Company; and
- (3) General corporate purposes



For the purpose of ascertaining the requirement and deployment of funds for Objects of the Offer, we have relied on :

- *Techno Economic Viability (TEV Report) dated June 17, 2025 issued by D&B in respect of the Proposed Facility;*
- "Project Cost Vetting Certificate" dated June 17, 2025
- Certificate from Statutory Auditors regarding details of loan obtained by the Company, outstanding loan amount, term and condition of such loan and its utilization and bank correspondence.

9. ***Build-up of existing share capital of the Company***

In relation to the build-up of the existing share capital of the Company, we have reviewed the statutory forms and resolutions filed with the RoC and statutory registers prepared and maintained by the Company. We have also relied on the diligence conducted by Practising Company Secretary appointed for the purpose of conducting secretarial diligence over the affairs of the Company.

10. ***Price information of past issues handled by the BRLM***


